14 It appearing that Plaintiff Vertical Doors, Inc., and  
15 Defendants Extreme Dimensions, Inc., Ryan Li, and Simon  
16 Cheng, have stipulated to entry of the following Order, IT  
17 IS HEREBY ORDERED AS FOLLOWS:

18 1. Extreme Dimensions, Inc., Ryan Li, and Simon Cheng  
19 (hereafter collectively "the Extreme Dimensions Defendants"),  
20 named defendants in the above-captioned action, along with their  
21 successors, general and limited partners, employees, agents,  
22 officers, directors and affiliates, including but not limited to,  
23 any and all other persons acting in concert with them, shall not  
24 manufacture, use, sell, or offer for sale, in the United States,  
25 or import into the United States, any vertical door conversion  
26 kits, and may not contribute to or actively induce others to do  
27 any of the above, except as follows:

THIS CONSTITUTES NOTICE OF ENTRY  
AS REQUIRED BY FRCP, RULE 77(d).

1 a) This paragraph does not apply to vertical door  
2 conversion kits lawfully purchased or otherwise lawfully obtained  
3 directly from Vertical Doors, Inc. (not from its distributors or  
4 any other source); and

5 b) The Extreme Dimensions Defendants may continue to  
6 provide customer service (but not replacement hinges) to its  
7 existing customers for their existing vertical door conversion  
8 kits, as is reasonably necessary to fulfill any obligations under  
9 any warranties to those customers (excluding replacement of  
10 hinges, kits, chassis plates, or swingarms).

11 2. Within 30 (thirty) days of entry of this Order, the  
12 Extreme Dimensions Defendants shall deliver to Vertical Doors,  
13 all vertical door conversion kits in their possession, custody,  
14 or control, for destruction and/or disposal by Vertical Doors.

15 3. Within 30 (thirty) days of entry of this Order, the  
16 Extreme Dimensions Defendants shall destroy all advertising and  
17 promotional materials, instructions manuals, pamphlets, and the  
18 like, in their possession, custody, or control, which refer to or  
19 relate to vertical door conversion kits.

20 4. Within 30 (thirty) days of entry of this Order, the  
21 Extreme Dimensions Defendants shall modify electronic advertising  
22 in their possession, custody, or control, including websites, to  
23 remove all references to vertical door conversion kits.

24 5. Within 30 (thirty) days of entry of this Order, the  
25 Extreme Dimensions Defendants shall provide a copy of this Order  
26 to their distributors, dealers, wholesale operations managers,  
27 retail operations managers, and any other party in the chain of

1 distribution of their vertical door conversion kits, not  
2 including the end users.

3 6. The court may retain jurisdiction over the parties to  
4 enforce this Order.


5 7. No bond shall be required by Vertical Doors in  
6 connection with this Order.

7 8. Nothing herein shall be construed as an admission by  
8 any party.


9 9. Promptly after notification of entry of this Order,


