I acknowledge that I am not a Vertical Doors, Inc. employee nor agent and that any action I may undertake in connection with this agreement or with racing, will be taken on my own behalf as an independent contractor. I specifically agree and will hold harmless and release Vertical Doors, Inc, the officers of Vertical Doors, Inc. employees, agents, divisions, subsidiaries and affiliates against any and all loss and liability for bodily injury, including death or damage to any person or property whatsoever. This shall include, but not limited to me, my spouse, crew or the public, as a result of and arising out of my use of Vertical Door products, or in any way arising out of the operations of any and all racing vehicles under Vertical Doors, Inc. sponsorship, personal appearances or as a result of the performance of this agreement. This paragraph shall survive the termination of this agreement and shall be binding upon my heirs, executors, administrators, successors and assigns.

If I breach any terms of this agreement, in addition to any other remedy Vertical Doors, Inc. may have, **VERTICAL DOORS, INC. MAY CHARGE ME** and I will promptly pay to VERTICAL DOORS, INC. the market price for any product(s) Vertical Doors, Inc. has supplied to me under this agreement. This agreement shall be in effect from the date of execution hereof and shall remain in effect as long as I drive or own a Vertical Doors, Inc. sponsored vehicle. This supersedes all prior agreements between parties.

The initial terms of this agreement shall run from the date it is fully executed by the parties until December 31 of that year and thereafter shall be automatically extended for one year terms, unless cancelled by either party, in writing, at any time during the initial or successive terms.
